23 March 2026

- A leading children's rights organisation has warned government plans to activate parts of the Immigration Act 2016 would leave many unaccompanied care leavers with no secure immigration status and without essential support when they turn 18, increasing risk of homelessness, destitution and exploitation. 16 March 2026

- Leading charities are urging the next Scottish Parliament to recognise unaccompanied children primarily as 'looked after children' rather than through the lens of immigration control. (Source: Morning Star)
- A recent UNICEF briefing highlights the rising number of children on the move globally and calls for stronger protection systems. (Source: UNICEF)

09 March 2026

- A young refugee who experienced homelessness and attacks following the Home Office's 28-day move-on period was part of a legal case that successfully challenged implementation of the policy, which should allow discretion where a person is at risk of homelessness. (Source: the Guardian)

23 February 2026

- A partnership of universities urges exemptions from the international student levy for PhD students, fully funded scholars and short-term exchange visitors, arguing these measures are needed to protect research talent and minimise harm to universities. (Source: Russell Group)
- A coalition of refugee and children's organisations has called for the Home Office National Age Assessment Board (NAAB) to be disbanded. The group argues that the NAAB is traumatising young people who seek asylum, wrongly classifying many as

16 February 2026
